# A review of the data privacy landscape heading into 2024

2023 was a turbulent year for the privacy industry to say the least. We saw Six new US States introduce privacy regulation (Iowa, Indiana, Tennessee, Montana, Oregon, Delaware, and Texas) alongside significant changes to regulation in Spain, China, India and the UK's eagerly anticipated Data Protection and Digital Information Act.

Despite the volume of new regulations and an ever-increasing number of violations around the Globe, 2023 did not see the privacy marketplace grow, the cutbacks across the technology industry saw in-house hiring grind to a slow pace early in the year and remain such after the major layoffs, this is, however, something we are expecting to see change significantly upon entering 2024 and predict a steady increase in hiring throughout 2024.

On the other hand 2023 was a fantastic year for the legal portion of the privacy world. With class-action suits at an all-time high, the demand for experienced privacy and cybersecurity counsel was at a premium. A trend we are expecting to continue in 2024.
